PURPOSE OF PROGRAM

The Laitram Matching Gift Program (“Program”) allows employees the opportunity to direct their donations and Company match to the eligible charity of their choosing within our strategic giving pillars: STEM Education, Health & Human Services, Youth & Workforce Development and Sustainability. Under the Program, Laitram will match dollar for dollar contributions made by employees to an “Eligible Charity” subject to the following conditions.

ELIGIBLE CONTRIBUTORS

Active employees of Laitram and its subsidiary companies.

INSTRUCTIONS

Employees must complete Section A and provide the entire Form (including this page) with his/her gift or receipt to the Eligible Charity.

An authorized official of the Eligible Charity will complete Section B and mail or email it to Laitram. Laitram will review Sections A and B and upon confirmation of eligibility, authorize a matching gift to the Eligible Charity. The employee will receive notification from Laitram when a matching gift is issued after the close of each calendar quarter.

ELIGIBLE CHARITY

Unless excluded below, U.S. organizations that are tax-exempt under Section 501(c)(3) of the Internal Revenue Code and are operated exclusively as a charitable organization.

ELIGIBLE GIFTS

Only charitable contributions to an Eligible Charity will be matched. The minimum individual “Eligible Gift” to be matched is \$25. The maximum aggregate annual contribution amount per employee is \$1,000. If board participation requires Company participation or an elevated donation beyond \$1000, that must be approved separately via Human Resources. The contribution must be a personal gift of the employee. It may be in cash, check, credit card, or securities that have a quoted market value. To further its commitment to corporate social responsibility, Laitram reserves the right to review organizations receiving matching funds and request documentation verifying receipt of donations from employees. In addition to the Exclusions and requirements specified herein, Laitram reserves the right not to match contributions to any organization whose purpose or program is not aligned with Laitram’s corporate social responsibility or giving pillars, objectives (e.g., Health & Human Services, Sustainability, etc.) or other policies.

EXCLUSIONS

Types of contributions or payments that are not eligible for the Program:

1. Individual school donations, school tuition, Matching Programs or Fees, parent association events and/or general school events

Non-exclusive list of organizations that are excluded from the Program and are not an “Eligible Charity”:

1. Political	2. Education (schools see above)
3. Professional, Business or Trade	4. Fraternal, Sport or Social
5. Religious organizations except those that: a. Are open to all individuals regardless of faith, b. Serve a secular purpose such as a food pantry, shelter, etc., c. Do not require participation in prayer, worship, or other religious activities as a condition to receiving services, and d. Do not use the individual donation or matching gift for religious purposes.	
6. Organizations that are, or whose owners, principals, managers, officers, members and/or affiliates are (1) listed as, or supporters of, any Specially Designated Nationals or (2) otherwise blocked persons by the United States’ Federal Government’s Office of Foreign Assets Control .	

ADMINISTRATION
